

SCHEDULE B: ADMISSION AND SELECTION ADJUSTMENT FACTORS

This Schedule is made pursuant to the *Admission Criteria and Selection (Higher Education Courses) procedure* and was approved by the Academic Board on 8 June 2022.

Detailed information regarding application and evidential requirements is available on the [Admission Adjustment Factors website](#).

Contextual Information

Eligible students will be ranked and selected into courses on the basis of academic merit, likelihood of success and the availability of places in accordance with the *Admission Criteria and Selection (Higher Education Courses) procedure*.

Selection rankings take into consideration factors that are likely to:

- a. have adversely affected a student’s prior academic achievement
- b. increase a student’s chance of success in their intended course, including:
 - i. previous academic achievement in particular discipline areas
 - ii. non-academic characteristics and/or capabilities.

Adjustment factors will be reviewed on an annual basis. Adjustments will be applied during the selection process in accordance with the following:

1.2	<p>Other Adjustments</p> <p>Subject Adjustments Applicants applying for an undergraduate course (or combined undergraduate/postgraduate course) on the basis of recently completed Australian secondary education may be eligible for subject adjustments. Subject adjustment points may be added to the applicants aggregate study score on the basis of study scores achieved in subjects considered by faculties to add value to their course application. 2. APPLICATION OF ADJUSTMENTS WITHIN THE SELECTION PROCESS

2.1	<p>Recent secondary education: Applicants applying on the basis of a recently completed Australian secondary education will have additional points added to their aggregate study score to determine an equivalent ATAR. Applicants are eligible for a maximum of up to 27 aggregate points (which will equate to an increase of no more than 12 ATAR points) inclusive of equity adjustments, subject adjustments and any course specific adjustments. The schemas for each category and caps applicable against each category are approved annually and published on the Admissions Adjustment Factors website. Note: the University applies a cap of 12 ATAR points.</p>
2.2	<p>Other applicants: Consideration will be provided within the selection process, and selection officers will be guided by the approved Deakin University Schema (below) applicable to applicants who have recently completed secondary education and the weighting of each category. Outcomes of this adjustment process will be equivalent, as far as reasonably possible, to the outcomes of the adjustments provided to applicants applying for admission on the basis of recent secondary education.</p>

3.	APPLYING FOR AN ADJUSTMENT
	Applicants seeking admission via VTAC are required to submit their application for consideration under equity adjustment categories in the manner prescribed by VTAC. Applicants seeking admission directly to the University, and applying for consideration under the Equity Adjustment categories should nominate their intention within the Deakin University Applicant Portal. All other categories are automatically applied.
4.	DOCTOR OF MEDICINE APPLICANTS
4.1	<p><i>Rural/Regional residency</i></p> <p>Applicants who meet defined rural and regional residency criteria have additional points added to the combined grade point average (GPA) and Graduate Australian Medical School Admission Test (GAMSAT) score. To qualify for an adjustment for rural/regional residency, applicants must have lived for at least 10 years cumulatively or any 5 years consecutively after birth in a place classified by the Modified Monash (MM) category as level 2-7 or Geelong MM1. Residence in:</p> <ul style="list-style-type: none"> • MM2 or Geelong MM1: an adjustment of 4% of the combined GPA and GAMSAT score • MM3-7: an adjustment of 8% of the combined GPA and GAMSAT score.
4.2	<p><i>Prior Clinical Experience</i></p> <p>Applicants who have completed one year (12 months) of full-time clinical practice as an AHPRA registered health professional, or in speech pathology or dietetics may have a 4% adjustment added to the combined GPA and GAMSAT score.</p> <p>Applicants with international clinical practice and registration that aligns with the professions listed on the AHPRA website including speech pathology and dietetics, may also be eligible to receive this adjustment (bonus).</p> <p>Applicants who claim the Work Experience adjustment (below) are not eligible to apply for this adjustment.</p>
4.3	<p><i>Financial Disadvantage</i></p> <p>Applicants who can demonstrate financial disadvantage which may have impacted on academic performance during their most recent qualifying degree may qualify for an adjustment. The following benefits are recognised as providing eligibility for the adjustment:</p> <ul style="list-style-type: none"> • all Centrelink income payments • Department of Veteran’s Affairs income payments. <p><i>Other Australian Federal or State Government income payments of similar amounts may be considered.</i></p> <p>StudyLink benefits (exclusive of StudyLink loans) apply for applicants from New Zealand.</p> <p>Applicants who are able to demonstrate that they have been in receipt of an approved Centrelink/StudyLink benefit for at least 12 months during their undergraduate degree, may have a 2% adjustment added to the combined GPA and GAMSAT scores.</p>
4.4	<p><i>Deakin Graduate</i></p> <p>Applicants who have graduated from Deakin University with an undergraduate or postgraduate degree by coursework may have a 4% adjustment added to the combined GPA and GAMSAT score. Applicants must have completed a minimum of two thirds of their course requirements at Deakin in order to be eligible for consideration. Recognition of Prior Learning will not count as having met the two thirds of the course requirement.</p>
4.5	<p><i>Work Experience</i></p> <p>Applicants who can demonstrate that they have gained a minimum of 2 years full-time employment experience in any area of work (consecutively or cumulatively over 4 years) may have a 2% adjustment added to the combined GPA and GAMSAT score.</p> <p>Applicants who claim the Prior Clinical Experience adjustment (see 4.2 above) are not eligible to apply for this adjustment.</p>
